DOROTHY OHLHAVER SCHOLARSHIP FUND

SCHOLARSHIPS GUIDELINES

Educational Training and Consulting will award a limited number of scholarships, based on the availability of funds. The scholarships may range from \$500-\$1,000 per academic year. ETC and its affiliates reserves the right to inquire on the progress of the recipient and receive copies of reports from field consultants, mentors, as well as transcripts from the recipient.

Institutional scholarships are provided to assist academically-deserving students. All scholarships and other financial aid already awarded will be taken into consideration when determining eligibility.

I. ELIGIBILITY REQUIREMENTS FOR UNIVERSITY

Recipients of the scholarship must be:

- A. Pursuing an early childhood Montessori degree.
- B. Enrolling for the first time, or a returning student with fewer than 90 commulative college credit hours.
- C. Enrolled for 6-12 hours.
- D. Have and maintain a satisfactory GPA (2.50-4.00).
- E. Maintain satisfactory academic progress and not be in default or owe a refund to any other college.
- F. U.S. citizen or eligible non-citizen.
- G. Not be related to any of the ETC Board Members.

II. ELIGIBILITY REQUIREMENTS FOR TRAINING CENTER

Recipients of the scholarship are required to:

- A. Pursue an early childhood Montessori certificate.
- B. Must be enrolled in a MACTE recognized Montessori training center, that awards credentials for early childhood.
- C. Must complete the course within the MACTE guidelines.
- D. Maintain academic requirements and not be in default or owe a refund to any other training center.
- E. U.S. citizen or eligible non-citizen.
- F. Not be related to any of the ETC Board Members.

III. APPLICATION PROCEDURES

- A. Complete and submit to Scholarship Fund Office, a Scholarship Application with the items listed below.
- B. Submit and official college academic transcript from all colleges previously attended.
- C. One page essay about yourself explaining your family background, personal interest, and why you want to further your education.

IV. SELECTION RECIPIENTS

Selections will be based on student's overall academic progress, extracurricular activities, leadership skills, and participation in community activities. All monetary funds will be paid directly to the institution or training center.

V. NOTICE OF AWARDS

Students will be notified by mail of any scholarship award or denial.

VI. RENEWAL OF SCHOLARSHIP

Scholarship may be renewed on an academic year basis, contingent upon satisfactory academic progress and availability of funds. Students must re-apply by the deadline for the next academic year (April-May). Please attach a separate sheet describing how the scholarship benefited you and why it should be renewed.

VI. REVOCATION OF AID

The Dorothy Ohlhaber Memorial Fund reserves the right, through its board members, to cancel any scholarship or aid awarded at any time if the applicant fails to meet the standards of academic progress, any other scholarship requirements, or falsifies information reported.
